#### A statement by Amy Falkowitz

I've been in fandom for a while; maybe not as long as some of you. And in general I've had a great time, and gotten to know a lot of wonderful people. And I've seen a concept come alive.

The IDIC. It's a beautiful symbol, folks. And its meanings are even more so. And most of us are good examples of those meanings. But there is something unkind and cruel among us.

It's the "love-letters". The nasty, malicious, threatening, and now, anonymous letters that are being sent to people. Hey, folks. IDIC is all of us. Fandom is all of us. And not one of us has the right to treat anyone else in such a manner. We are all in this together -- it may be a cliché, but it's awfully true. When one of us stoops to such childish meanness, it reflects on all of us. And therefore only we can do anything about it. I ask you to think about it. Maybe you can do something about it. At least consider what this says about fandom. We espouse certain ideals, I think. But if this sort of thing goes on, how can we really live and believe in them?

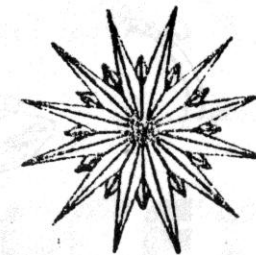
